# SUMMARY OF SCHOOL DATA ANALYSIS AND/OR COMPREHENSIVE NEEDS ASSESSMENT

#### 1. What does an analysis of your school data and/or a comprehensive needs assessment tell you about the school's strengths?

Overall, Cameron has scored relatively well on the EOG's for reading, which supports the fact that our implementation of the county framework has been successful. We continue to support our struggling readers with 45 minutes of LLI everyday as well. We maintain low numbers in 3rd grade who need to attend the Rita summer camp. This year our Science EOG scores. According to our TWC Cameron is overall a great place to work, and staff is provided leadership opportunities, and they work on clean and safe campus.

#### 2. What does the data analysis and/or comprehensive needs assessment tell you about the school's gaps or opportunities for improvement?

According to our data our school has struggled with Math EOGs for the past few year's in 4th and 5th grades. Our 3rd grade scores although significantly higher than 4th and 5th have declined for the past 3 years. 3rd grade in 2014 scored an 86% proficiency, 4th gr. 50%, and 5th gr 36%. 2015 3rd grade 68%, 4th gr. 36%, 5th gr. 36%. 2016 3rd grade 57%, 4th gr 34%, 5th gr 41%. There is a large proficiency gap with our SWD 16% and our EDS 35.2%. According to the TWC survey data that overall school leadership is a real concern, as is parent and community involvement/communication.

After collecting staff data, and meeting with our PAC it was determined that parent involvement was low due to lack of communication, staff morale was very low, and teachers did not feel valued or appreciated. This data was collected through notes, personnel meetings, and a Google staff survey.
